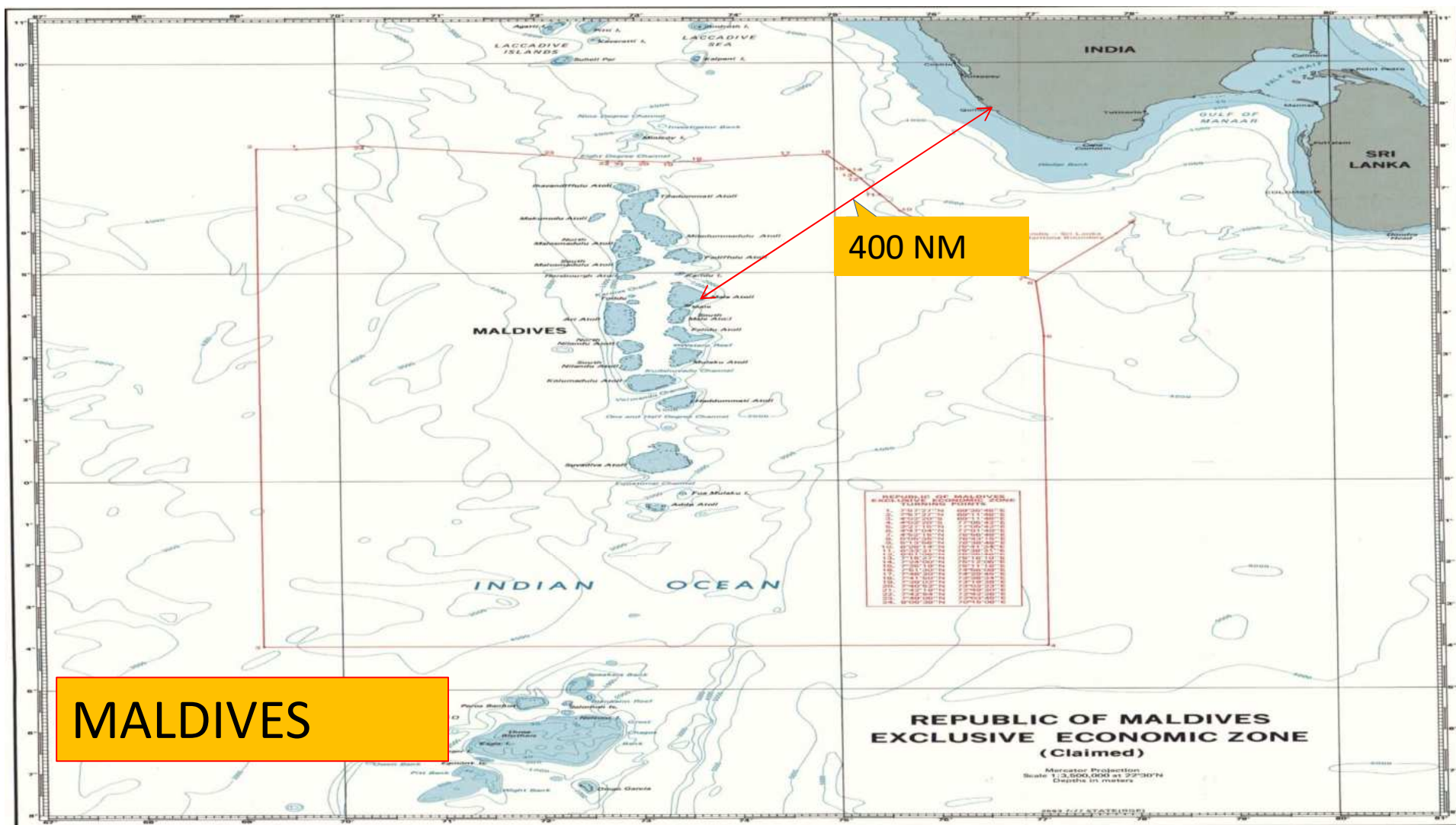

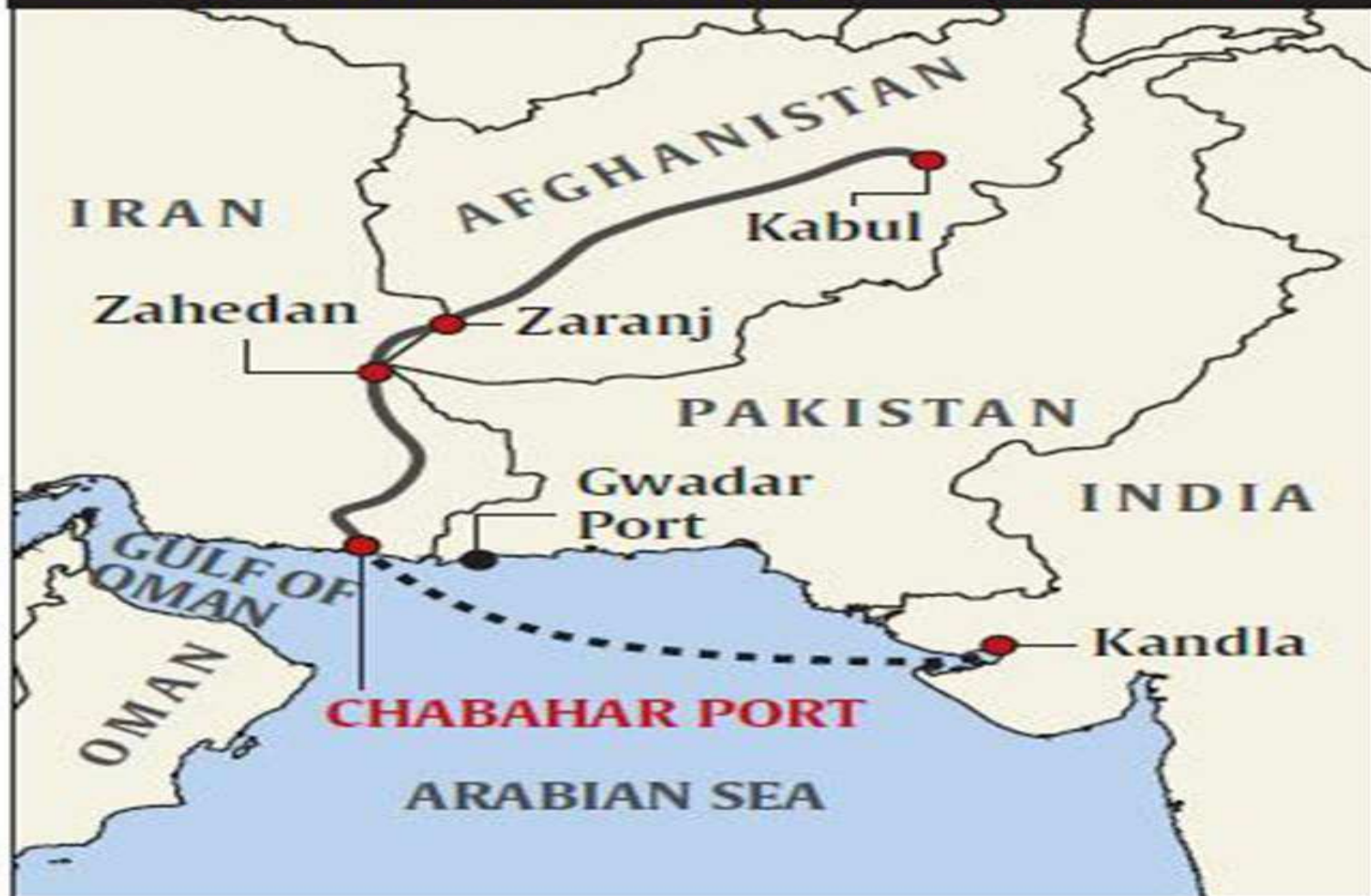

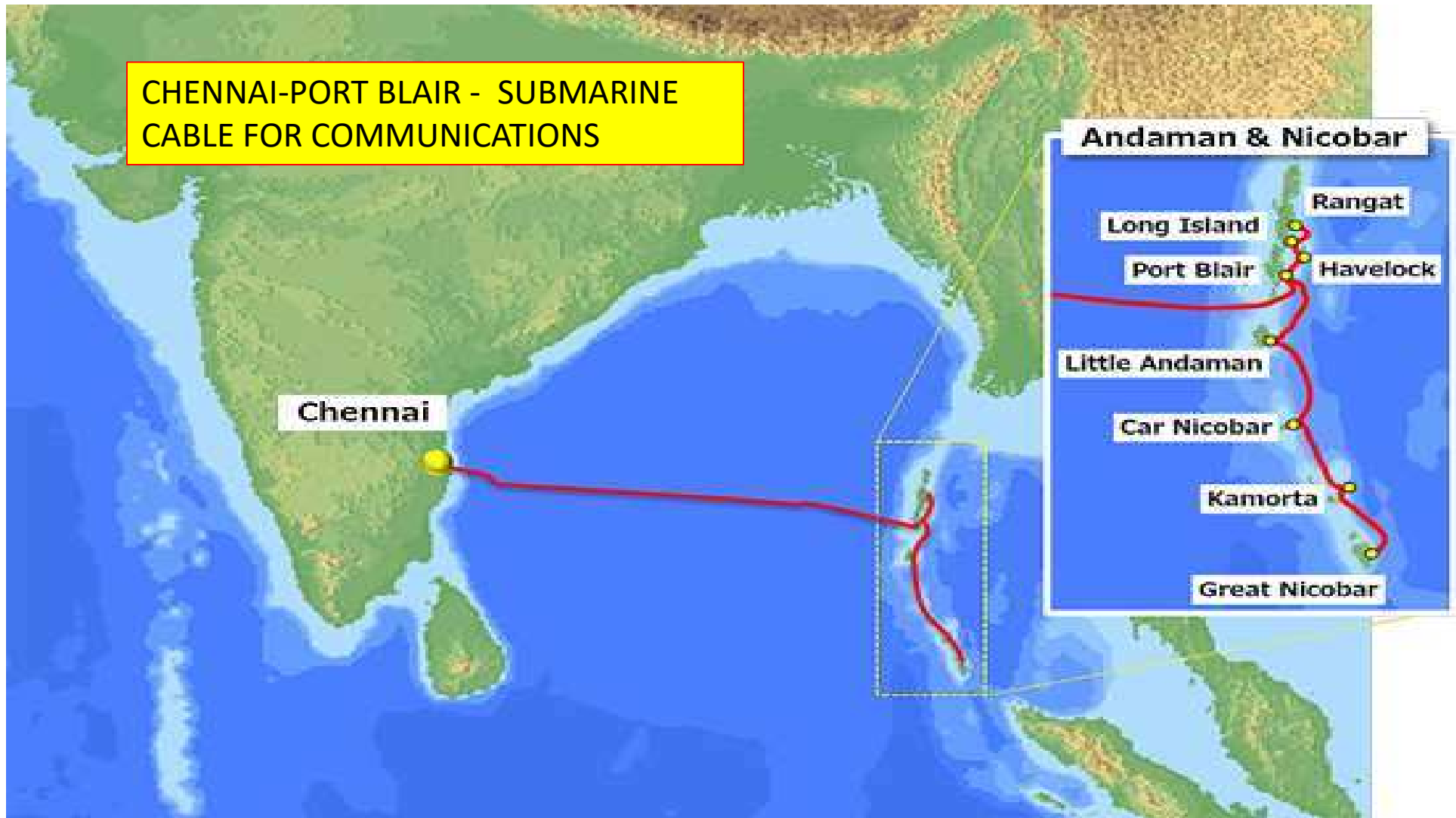

SEA BED ALLOTTED TO INDIA BY ISA FOR MINING

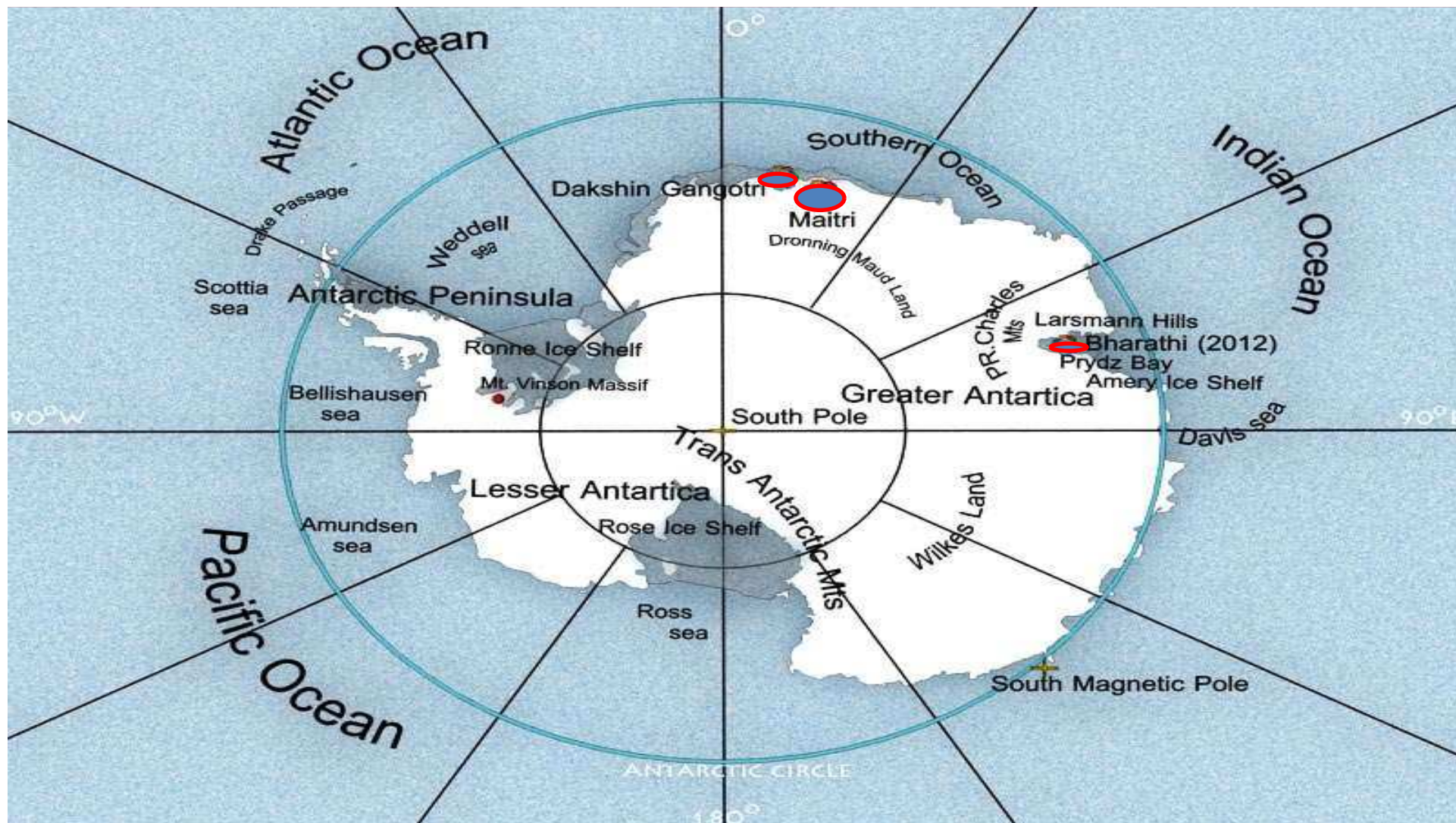

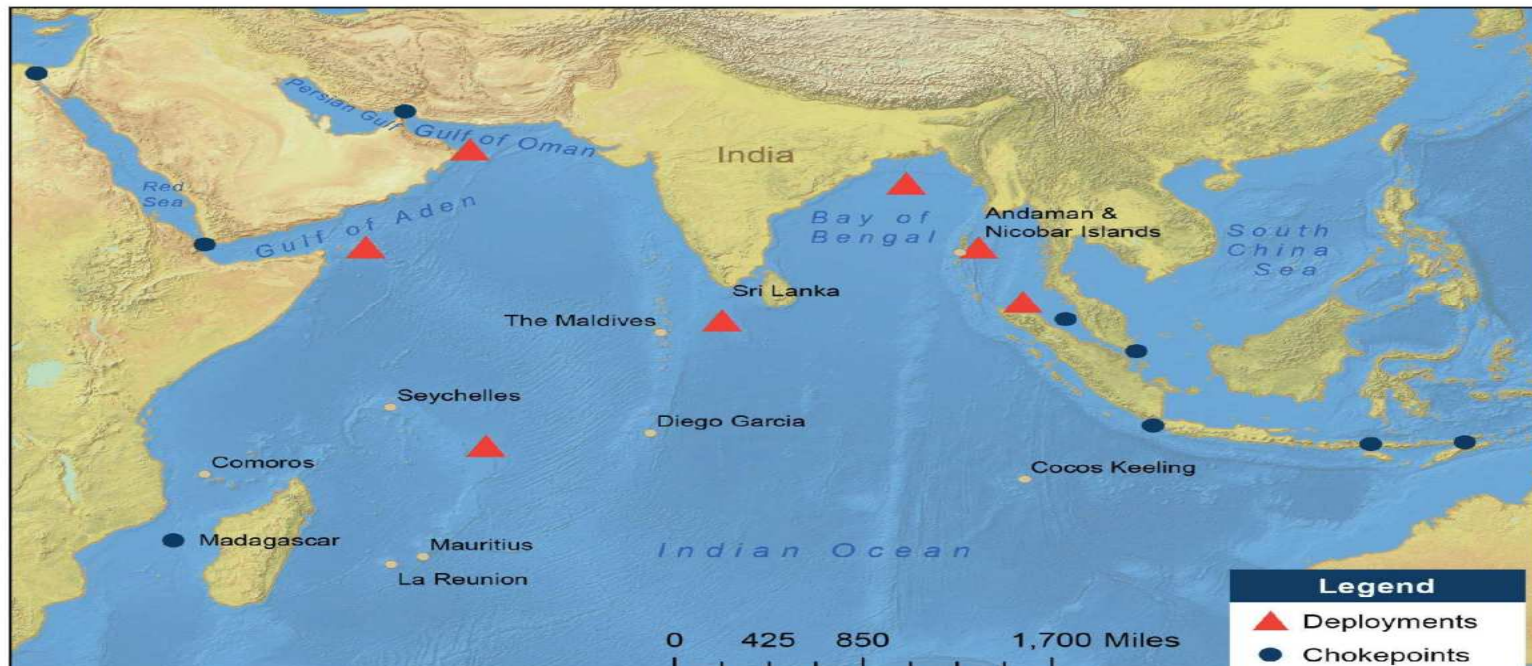

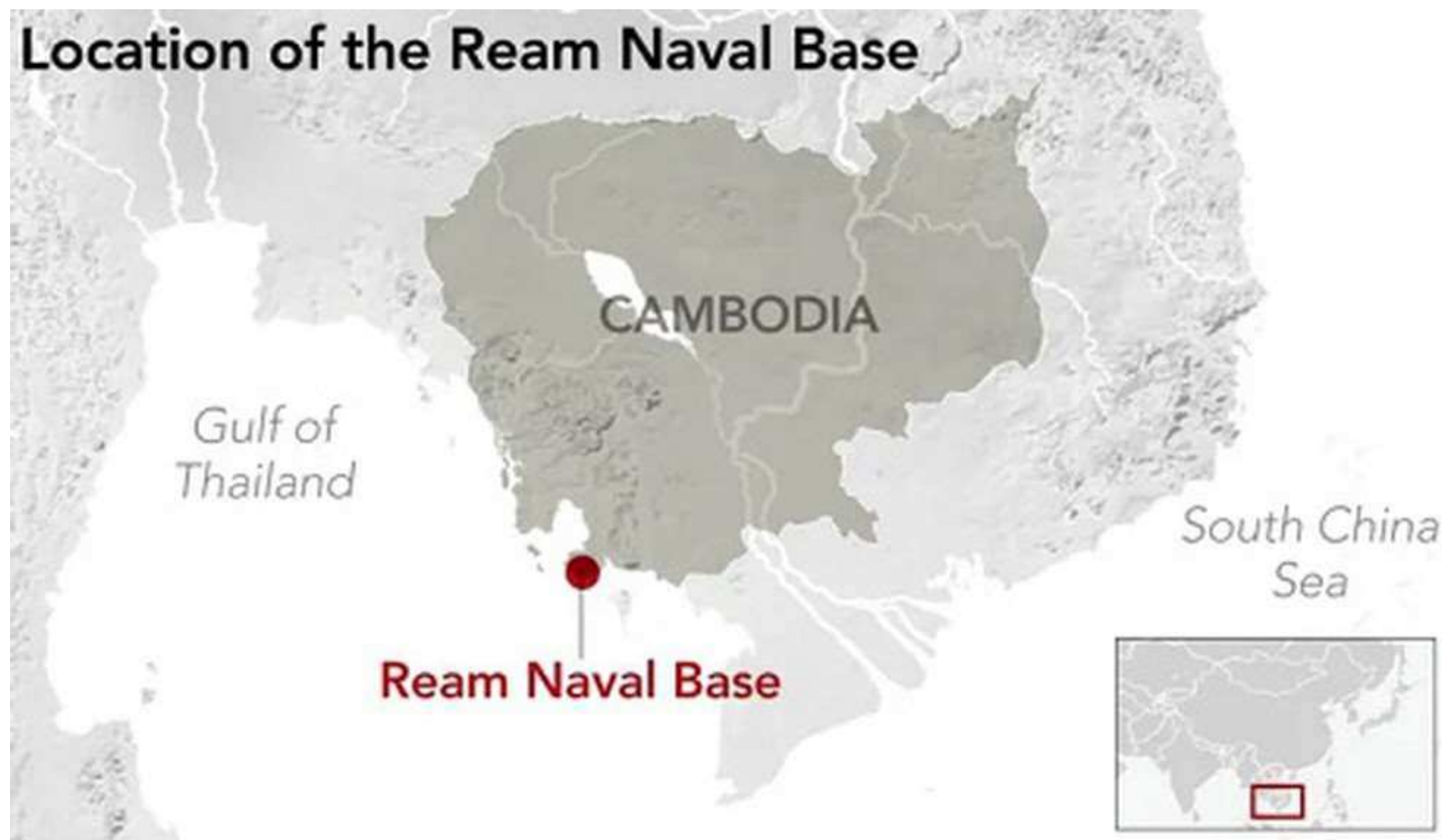
