2. Explain the concept of Nation State along with its features. Also highlight the role of Nation State in securing International Security with the help of relevant illustrations.

3. *Diplomacy is “the application of intelligence and tact to the conduct of official relations between governments of independent states”- Sir Ernest Satow.* In the light of this definition explain the importance of diplomacy in maintaining international peace.
4. Conflict is “a disagreement through which the parties involved perceive a threat to their needs, interests or concerns.” What are the components of a conflict in the triad? Explain different types of Conflicts with examples.
5. *“Peacekeeping has always been highly dynamic and has evolved in the face of new challenges”.* How do you see the role of International Organisations in building peace in the world in current times?
6. Define Dispute. Explain the distinction between peaceful/pacific and coercive/compulsive methods of settlement of International Disputes.
7. *“Globalization has necessitated a change in the role of state.”* Do you agree? In the light of the above statement, briefly explain the impact of globalization on the functions of the State. Also write on the impact of globalization on the theories of International Relations.
